EUPHA shares concern on decision to decrease DG Health portfolio

EUPHA shares the widespread concern that has been voiced by civil society organisations at the decision to transfer responsibility for drugs policy and the European Medicines Agency back to the Directorate-General for Enterprise and Industry, reversing the 2009 transfer of these responsibilities to the Directorate-General for Health. We regard this as an alarming and retrograde step with potentially profound implications for public health, quality of medicines, and the security of European citizens. We have three main concerns.

e-Cigarettes commentaries in IJPH free online

The use and regulation of e-cigarettes is hotly debated and the [World Health Organization](#) WHO, as the global authority for public health, has come under pressure from both pro-e-cigarette as well as contra-e-cigarette advocates. In contrast to the traditional tobacco debate with the public health research community arguing on one, and the tobacco industry and its constituencies on the other side, the current stage of the e-cigarette debate finds honest and independent public health scientists on both sides. Although it is obvious which one the tobacco and e-cigarette industries applaud, the more interesting question is why the public health community does not yet speak with “one voice”. The Nation's Health: Wearing a helmet while cycling can keep you safe

As kids head back to school, college students traverse campuses and the weather starts cooling off, fall is a great time for a bicycle ride. After all, biking is a great way to stay active and healthy. [Research shows](#) that it can be good for the environment, too. Whatever reason you decide to ride a bike, there's one important accessory to include: a helmet. Cyclists who [ride without helmets are at an increased risk](#) for head injury, according to the Centers for Disease Control and Prevention. How many cyclists ride without wearing a helmet? Study: Healthy lifestyle behaviors may prevent 80 percent of heart attacks

Five recommended health behaviors may prevent four out of five heart attacks in men, a new study suggests. Middle-aged and older men were much less likely to have heart attacks over an average of 11 years if they drank moderately, didn't smoke and did everything right on the diet, exercise and weight fronts, the study found.

Only about 1 percent of men involved in the study fit into this ultra-healthy-living category. But they were 86 percent less likely to have heart attacks than those who ate poorly, were overweight, exercised too little, smoked and drank too much alcohol, the researchers said.

Smoke-free building policies cut indoor exposure: study

Apartment dwellers who don't smoke still can't escape second-hand smoke completely, but in smoke-free buildings exposure to the tiny particles in cigarette smoke may be cut by half or more, according to a new study.

Researchers in Boston monitored indoor air at public housing projects transitioning to a smoke-free policy and tracked tobacco smoke as it traveled to adjacent apartments and down common hallways. <http://www.publichealthnewswire.org/>

E-cigs don't help cancer patients quit smoking

New research raises doubts about the possible benefits of e-cigarettes for people with cancer. Smokers with cancer who used e-cigarettes along with traditional cigarettes were more dependent on nicotine than those who didn't use the devices, a Memorial Sloan-Kettering study found. These patients were also just as likely — or less likely — to have quit smoking than patients who didn't use e-cigarettes.

The study, published online Sept. 22 in *Cancer*, involved almost 1,100 cancer patients who smoked. Between 2012 and 2013, the patients were enrolled in a tobacco treatment program at a comprehensive cancer center. <http://www.webmd.com/cancer/news/>
